Sir,

I am to report that today that is 05/06/2023 at @ 5:30 pm received an information that some illegal arms and ammunitions were kept conceal at the locality of Khomidok near Arapati School. Accordingly a team led by Insp. Kh. Henery Singh OC/CDO-IE, Insp. Kh. Pathou Meetei OC/HNG-PS/IE along with my team including other 04 (four) teams of CDO/IE under the supervision of SP-IE Shri Ksh. Shivakanta Singh, IPS, SP/IE rushed to the sourced area. That on arrival, none of the family members is found at the sourced house (residence of Md. Aziz @ Yumkhaibam Ajit s/o Yumkhaibam Samad of Khomidok Mayai Leikai, HNG-PS/IE). Accordingly, contacted the concerned executive magistrate as well as other civil witness and conducted house search in their presence.

That, during the house search, six fully loaded with 20 live rounds each of INSAS Rifles magazine, two pair of ear ring (appeared to be of gold), a sum of Rs. 1,10,000/- (Rupees one lakh ten thousand) only and 29 (twenty nine) soap cases containing suspected Heroin No.4 Powder were found concealed inside the Almirah.

That, on weighing of the said suspected Heroin No.4 powder it is found to be 350 gms approx. including the weight of the small transparent plastic. Accordingly, all the illegal items founds, were seized observing necessary formalities at 6:20 pm. Further, the suspected Heroin No.4 powder were properly packed and sealed in presence of executive magistrate and local civil witness.

Therefore, the illegal seized items were handed over to you for further necessary action.
