Sir,

I am to state that today i.e. 06/06/2023 at about 10:00 am a team of Finger Print went to the office of Finger Print Bureau, Pangei, located in the campus of Forensic Science Laboratory, Pangei, to get some official documents and it was found that the front gate of the office of the Finger Print Bureau was opened by breaking the lock of the gate and the office was found vandalized by unknown persons. On further inspection it was found that 8 (eight) doors of the building were broken and the rooms were ransacked. In one room, the lock of one wooden cupboard, which is used to store chemical, was found broken and opened. Further, it is found that many pigeon holes shelves which are used to store fingerprint slips were either damaged or opened. 3 (three) numbers of crime scene investigation kit were vandalized. Further one storeroom which is used to store fingerprint kits was vandalized and ransacked by damaging the door. On enquiry it is found that the office of FSL, Pangei was vandalized by a large number of unknown persons on 28/05/2023 and so it is suspected that our office was also vandalized and ransacked on 28/05/2023.

It is therefore, requested to kindly take necessary legal action against the unknown accused persons.
