I, the undersigned, a victim presently taking relief/ shelter at Relief camp, EBCC Dorcas Veng, New Lamka have the honour to state the following for your kind intervention and favourable action that, on 7th May 2023 at around 5:00-6:00Pm, unknown Meitei goons armed with deadly sophisticated weapons forcefully entered our house and looted/ robbed all the valuable items and vandalized our rented house and the remaining household/ domestic goods. (Details of the particular items looted and destroyed is enclosed herewith for easy reference)

That, the estimated value of properties destroyed, looted and burnt is estimated to be worth approximately Rs. 9,70,000/- (Rupees Nine Lakh Seventy thousand) only
