With due regard, I the under signed have the honour to report to your esteemed OFFICE for further necessary action hereafter.

That, Sir, on the fateful night of 5th June 2023 at around 9:30 pm, unknown miscreants suspected to be Arambai Tenggol, Kangleipak Kanba Lup and Meetei Leepun, numbering about 450-500 attacked my residence house at K. Vengnom, Mantripukhri IGAR South under Heingang Police Station, Imphal East District. Consequently, the miscreants broke my quarter and looted all my properties. The value of looted/damaged properties is estimated to be about Rs. 25,26,400/- (Twenty five lakhs twenty six thousand and four hundred) approximately.

Due to the prevailing situation, I could not report to my concern Police Station and in due time.

I therefore request you to take necessary legal action against the culprit.
