Sir,

I have the honour to state that, on 4-5-2023 at around 10:30 am some unknown miscreant suspected to be members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 500-600 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our Locality at Koirengei Opp. CMC near river bank, Imphal about 48 km South. They looted all the moveable properties including cash, Jewellery, Furnitures, Utensils, Clothes and grains etc.

The approximate value of lost property is calculated at about Rs. 40-50 lakhs.

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
