I have the honour to state that, on 4-5-2023 at around 08;00 am some unknown miscreants suspected to be members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 600 persons carrying deadly weapons committed an Anti Social elements at Luwangsangbam Leikai, Koirengei Imphal East District, Manipur about 46 km South from Saikul PS.

That, my Ulta Bus bearing Regd. No. MN06B 1366 which was parked nearby roadside, have been totally burnt down to ashed after removing and looting all the serviceable parts. The approximate value of lost properties is calculated at about Rs. 26,00,000/- (Twenty six lakhs).

It is, therefore, requested yoy to kindly register a regular case and take necessary legal action against the culprits according to law.
