Sir,

I have the honour to state that, on intervening night of 4-05-2023 some unknown miscreants suspected to be a member of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and world Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 500 – 600 person carrying sophisticated weapons like AK Rifles , INSAS and .303 Rifles, forcefully entered our locality at K Vengnom, chumbreithong Maning Leikai, IGAR South, Mantripukhri, Imphal East, about 45 km South, They looted all the moveable properties and cash, including one Alto car No. MN 03a 2870, Important Documents/ Educational Certificates, Jewellery, Furnitures, Utensils clothes and grains. Etc.

The approximate value of lost property is calculated at about Rs. 40 -50 Lakhs.

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
