Sir,

I have the honour to state that, on 30-05-2023 at around 06:00 am some unknown miscreants suspected to be members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000 persons carrying sophisticated weapons like AK, SLR< INSAS and .303 rifles forcefully entered our locality, K. Vengnom Mantripukhri IGAR South, Lamlongei, Imphal East district, Manipur about 46 Km South from Saikul _Ps. After looting all the moveable properties like furnitures, Electronic Gadgets and appliances, Utensils, clothes, Kitchen wares, Ornaments, Jewellery, books, food and grains, including building materials etc. they burnt down my house to ashes leaving us homeless. The approximate value of lost property is calculated at about Rs. 1,80,00,000/- (one core eighty lakhs)

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.


