Sir,

I have the honour to state that, on 05-06-2023 at around 08:20Pm some unknown miscreants suspected to be members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 500 persons carrying sophisticated weapons like AK, SLR, INSAS and .303 rifles forcefully entered our locality, K. Vengnom, Kontha Khabam near IGAR South, Imphal East District, Manipur about 46 km South from saikul- Ps. They vandalised and looted all the moveable properties including one Pulsar bearind Regd. No. MN 01Z 1573 and one Vespa Scooter bearing regd. No. MN1 AF 3092, Furniture, Jewellery, Utensil, Clothes, electrical and electronic items, books, Gym equipments, Electric rice mills, food and grains etc. The approximate value of lost property is calculated at about Rs. 2,50,00,000/- (two crores fifty lakhs).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
