I have the honour to state that, On 29-05-2023 at around 08:00pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kanglipak Kanba Lup (KKL), Arambai Tenggol and world Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000 persons carrying sophisticated weapon like AK, SLR, INSAS and .303 rifles forcefully entered our locality, k. Vengnom Mantripukhri near IGAR South, Imphal East District, Manipur about 46 km South from Saikul –Ps. After looting all the moveable properties along with all the furniture, Electric and Electronic appliances, Utensils, Clothes, Kitchen wares, Ornaments, Jewellery, Books, food and grains etc. They burnt down my house to ashes leaving us homeless. The approximate value of lost property is calculated at about rs. 3,00,00,000/- (three crores).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
