One mobile phone (Redmi 10) bearing IMEI no. 866131066651346/78 & 866131066651353/78 along with one Airtel SIM card bearing no. 8991160990020940211U was seized mobile from his possession by observing necessary formalities at 4:55 pm.

Therefore, the arrested person along person along with the seized mobile phone is being handed over to you taking up further necessary legal action against him.
