Sir,

I am to report that today i.e. 3<sup>rd</sup> February, 2023 at about 4:00 pm on receipt of a specific information from 16 AR corroborated with our own intelligence about the presence of one active member of the outfit KYKL (SOREPA group) at Ahallup area of Imphal East District. Based on the said information, a team of CDO/IE unit led by myself rushed to the said area and conducted a random frisking and checking to the suspected passersby at Ahallup Thongkhong, Imphal East. In that, one suspected person was detained for verification at Ahallup Thongkhong, Imphal East at 4:30 pm. On checking his body, one mobile phone was found and recovered from his front right pant pocket. On verification, the detainee identified himself as one Khaidem Angousana Singh @ Lukhoi (24) Yrs S/o Kh. Ningthou Singh of Kangmong Langoljam Awang Leikai, Nambol PS, Imphal West District an active member of the outfit KYKL (SOREPA group). On further Verification, the detainee stated that he joined the said outfit through one Moirangthem Naoba Meitei of KYKL (SOREPA group) in the month of January, 2023 and presently working under the command of one Mr. Pathou @ Angou @ Laingou of KYKL – (SOREPA group). He further stated that, on the advice and instruction of the said Mr. Pathou @ Angou @ Laingou of their outfit he came to Imphal on 13<sup>th</sup> of January, 2023 from Namphalong, Myanmar to recruit new cadres to their outfit.

So, the detainee was arrested from the spot i.e. Ahallup Thongkhong, Imphal East District at 4:50 pm by observing necessary Formalities. One mobile phone (Redmi 10) bearing IMEI no. 866131066651346/78 & 866131066651353/78 along with one Airtel SIM card bearing no. 8991160990020940211U was seized mobile from his possession by observing necessary formalities at 4:55 pm.

Therefore, the arrested person along with the seized mobile phone is being handed over to you taking up further necessary legal action against him.
