Sir,

I have the honour to state that, on 28/05/2023 at around 07:30pm some unknown miscreants suspected to be a members of Meitei youth Organizations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule tribe Demand Committee (STDC) numbering about 1000 persons carrying sophisticated weapons like AK, SLR, INSAS and .303 rifles forcefully entered our locality, Phainom Veng, Lamlongei, Imphal East District, Manipur about 46 Km south from Saikul –PS. After looting all the moveable properties and cash along with 2 (two) Nos. of Two wheelers, all the Furnitures, Electrictronic appliances, Utensils, Clothes, Kitchen wares, Ornaments, Jewellery, Books, food and grains about 30 bags etc they burnt down my house to ashes leaving us homeless. The approximate value of lost property is calculated at about Rs. 2,00,00,000/- (two crores).

It is therefore, requested you to kindly register a case and take necessary legal action against the culkprits according to law.
