I have the honour to state that, on 04/05/2023 at around 07:00 pm some unknown miscreants suspected to be a members of Meitei youth Organizations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule tribe Demand Committee (STDC) numbering about 700-800 persons carrying sophisticated weapons like AK, SLR, INSAS and .303 rifles forcefully entered our locality, Phainom Veng, Lamlongei, Imphal East District, Manipur about 43 Km south from Saikul –PS. They vandalized my house and looted all the the moveable properties and cash (money) including all my household properties like Furnitures, Jewellery, Electronic gadgets, Kitchen wares, Utensils, Clothes, foods and grains etc. The approximate value of lost property is calculated at about Rs. 2,00,00,000/- (Two crores).

It is therefore, requested you to kindly register a case and take necessary legal action against the culkprits according to law.
