On further examination, he (Md. Hasan) disclosed that some arms were kept concealed inside his house. Accordingly, by observing due formalities searched was conducted and the following arms were seized on his production i.e. (i) One 9 mm carbine 1A1, B/Regd. No. 15227690 SAF 1992 with one empty magazine marked as 'S' (ii) One .22 pistol marked as Star, Butt No. CO 390612 with one empty magazine (iii) One Air pistol marked as Bond as well as a sum Rs. 2,50,000/-(two lakhs fifty thousand) in cash stated to be proceeds from the selling of weapons (one INSAS LMG & one 9mm pistol) and the four wheeler vehicle Tata ACE HT Khaki in colour, B/ Regd. No. MN07C/4431 used in transporting the said sourced weapons along with one mobile phone (iphone X) bearing IMEI no. 356725081248975 along with one Airtel SIM card bearing no. 8991160990004992950U by observing necessary formalities at 10:35 am and arrested him at 10:40 am.

In the swift follow up action the teams and the three arrestees along with seized articles rushed to the house of Md. Rashid and detained him. On his spot interrogation, he confessed that he sold the weapon with Md. Hasan and corroborated the statement of Md. Hasan. On further examination he disclosed that some arms & ammunitions were kept concealed inside his residence. Accordingly the following arms & ammunitions were seized from his production i.e (i) Two 5.56 mm INSAS Magazine marked as LOT-453/2012 D.S. CAT No. 1005007783 (ii) One .303 LMG Magazine marked as SAS 2007 Magazine 7.62 mm. 3A 1005000342 (ii) 21 Nos. of 7.62 mm live ammunition along with one mobile phone (Nokia TA 1456) bearing IMEI no. 350398051618167 & 350398051618175 along with one Airtel SIM card bearing no. 899116099001784457U and one SUV (Mahindra Bolero Pickup), white in colour, bearing regd. no. MN04P/1374 by observing due formalities at 11:05 am. So, he was arrested from the spot i.e. 11:10 am by observing necessary formalities.

Further, one bayonet with cover marked as 5787 & 15,One bayonet with cover marked as YR/2018 MEW, One bayonet with cover marked as 6306 & One bayonet with cover marked as RFI 85 (appeared to be the snatched /looted weapon from Manipur Police Department) were found abandoned at an isolated area of Heikrumakhong near Masjid at 11:30 am. Accordingly, the same were seized observing necessary formalities.

Therefore, the arrested persons along with the seized articles were being handed over to you for taking up further necessary legal procedures against them.

Sir,

I have the honour to report that today i.e. 26/06/2023, based on the credible input about presence of a Gang of arms smugglers in and around Heikrumakhong area under HNG-PS, IE a combined teams of IE District Police led by ASP(Ops) Shri N. Herojit and assisted by Inspt. Kh. Henery, OC/CDO and Inspt.Kh. Pathou Meetei, OC/HNG-PS, one team of HNG-PS and a team of 16 JAT Regiment & 4th AR led by Major L. Surchandra under the overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP/IE conducted search operation in the general area of Heikrumakhong , HNG-PS, IE in presence of executive Magistrate/IE (SDC-HNG/IE).

As per the input received, the teams moved to the residence of one Md. Nawaz (30) yrs S/o Safuruddin @ Md. Safur of Heikrumakhong, Khomidok Maning Leikai but he was not present at his residence. Accordingly his family members called him up through his mobile phone and when interrogated by police team over phone he disclosed that the sourced weapon (one INSAS LMG & one 9mm pistol) which were looted from 6th IRB Pangei on 28/05/2023 were handed over to Md. Nursafi (33) yrs S/o Md. Nizam of Heikrumakhong Kewa Makhong. Further it is also learnt that Md. Nawaz is a personnel of AR (Assam Rifles) presently posted at Nagaland (25th AR).

As disclosed by Md. Nawaz the teams rushed to the house of Md. Nursafi and detained him. Accordingly on spot interrogation, he disclosed that the weapons (one INSAS LMG & one 9mm pistol) handed over to him by Md. Nawaz were further handed over to one Md. Sanayai (46) yrs S/o (L) Md. Achou of Khomidok Sorok Mapal, IE. As such Md. Nursafi (33) yrs S/o Md. Nizam of Heikrumakhong Kewa Makhong was arrested at 09:30 am, by observing necessary formalities and seized one mobile phone (Redmi 899116090017131515U at 09:35 am.

Further as revealed by Md. Nursafi the teams along with him rushed to the house of one Md. Sanayai and detained him. That, on spot interrogation, he disclosed that the said weapons were further handed over to Md. Hasan (40) Yrs S/o (L) Md. Abdul Rahim of Kairang Awang Leikai, Imphal-East and he (Md. Sanayai) was arrested at 10:10 am by observing necessary formalities and seized one mobile phone (Redmi Note 10) bearing IMEI 863845057088233/07 & 863845057088241/07 along with two SIM cards bearing no. Airtel – 8991160990005523458U and Jio – 89918650500009047332 at 10:15 am.

In the follow up action the teams along the two above arrestees rushed to house of Md. Hasan (Follower of 3rd IRB under Follower No. 13F042047) and detained him. On spot interrogation, he disclosed that 5/6 days before the weapons were sold to one Thangboi (full particular unknown) who is suspected to be Kuki militant in connivance with Md. Rashid Ali (50) Yrs S/o (L) Md. Achou of Khomidok Sorok Mapal, Imphal-East. They went to Kanglatombi in one four wheeler vehicle (TATA ACE-HT bearing registration No. MN07C-4431) and handed over to Thangboi at a village near Kanglatombi and received Rs. 6,00,000/-(Six lakhs only). Out of which Hassan gave Rs. 1,00,000/- (one lakh only) to Md. Rashid Ali.
