Sir,

I have the honour to report that today i.e. 27/06/2023, based on the credible input about presence of a Gang of arms smugglers in and around Kairang Tera Makhong area under HNG-PS, IE a combined teams of IE District Police led by ASP(Ops) Shri N. Herojit and assisted by Inspt. Kh. Henery, OC/CDO and Inspt. Kh. Pathou Meetei, OC/HNG-PS, one team of HNG-PS led by ASI Y. Johnny Singh, a team of 4th AR led by Major S Pangeijam and a team of 16 JAT Regiment led by Major L. Surchandra under the overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP/IE conducted search operation in the general area of Kairang Teramakhong, HNG-PS, IE in presence of executive Magistrate/IE (SDC-HNG/IE).

As per the input received, the teams moved to Kairang Teramakhong area and conducted search operation at suspected area. On further searching near the river bank of Kairang Teramakhong one cement bag container was found abandon and conceal at swampy grass growing near the river bank. On being suspicious the cement bag container was checked and found huge arms and ammunitions suspected to be looted from different Armed Battalions. The abandoned arms and ammunitions were seized by preparing a seizure memo after observing due formalities at 07:30 am.

The details of the seized arms and ammunitions are:-

- 1) One AK-56 Bearing/Regd No-10081 along with one empty magazine
- 2) One AK-56 Bearing/Regd No.28263 along with one empty magazine
- 3) One Sten Gun without any description, black in colour
- 4) One SMC Carbine Bearing/Regd No.DD3206 without magazine
- 5) One .32 pistol Bearing/Regd No.05897 having marked Indian Ordnance Factory
- 6) One Country made pistol without any description, steel in colour
- 7) One .32 Auto pistol made in USA marked as 765MM along with one empty magazine
- 8) Two nos. of bayonet without any description along with its cover
- 9) One INSAS LMG empty magazine
- 10) One INSAS Rifle empty magazine and
- 11) 218 nos. of .303"live ammunition.

Therefore, the seized articles were being handed over to you for taking up further necessary legal procedures.
