With due respect, I the undersigned have the honour to state that the following few lines for your kind consideration and necessary action.

Since, 1<sup>st</sup> June 2023, the stock register maintained (computerised) by me and the output/sold from the godown directly have some differences. Thereby, I paid a surprise visit at the godown located at Luwangsangbam near BSF gate and crossed checked the physical availability of the goods and the computerised stock registered.

In which the following goods i.e. (1) Krack Jack Biscuits (Rs 10) :- 1020 cases (2) Krack Jack Biscuits (Rs 05) :- 944 cases (3) Happy Happy Biscuits (Rs. 05) :- 950 cases (4) Parle G biscuit (rs. 10) :- 900 cases (Total amount of Rs. 30,00,000/- (thirty lakhs) approx) were found missing from the godown.

It is learnt that Pintu Yogi (24) yrs S/o Ram Kishan of Bosana, District :- Sikar – 332025 State Rajasthan (Godown in-charge) had deliver/sold the said missing goods voluntarily and dishonestly without my knowledge. Thereby, wrongful gain of about Rs. 30,00,000/- (thirty Lakhs) was created by Pintu Yogi for himself in which wrongful loss of the said amount is cause to me.

It is therefore, most respectfully prayed that your goodself be pleased take an appropriate legal action against the above mention culprit
