I have the honour to report that today i.e. 29/06/2023 at around 02:00 pm, while I was on duty at Vaiphei Veng, Lamlongei Mantripukhri two unknown persons intruded inside the Vaiphei Veng village and started covering videos of the already destructed houses. In the meantime, I approached them and inquired about their identities and motives. In which they identified themselves as (1) Biswajit Dev (20) yrs S/o Ashok Kumar Dev of Phayeng Makha Leikai, IW A/p Old Lambulane, IW & (2) Ranjeet Kumar (30) yrs S/o Satnarayan Singh, Ward No. 8, Khesrahi Urf Ragghunathpur, Vaishali, Bihar-843114, A/p Old Lambulane, IW and further disclosed that as instructed by one Mr. Momun Vaiphei both of them had covered a videograph of destructed location at (1) Paite Veng, Kwakeithel, IW (2) Haokip Veng Mahabali Porompat, IE (3) Vaiphei Veng Lamlongei Mantripukhri, IE inhabited by Kuki brothers.

Mentioned may be made that the state Police department, esteem state Govt. and Central Govt. in particular are on the marked to bring peace and tranquility in the prevailing situation of the state of Manipur.

That, their act is prejudicial which could deepen the already inflicted wounds created between the two communities and further flare up the almost normalize situation of the state of Manipur and threat to the security of the state.

Accordingly, three mobile phones, two wheeler B/No MN 01 AJ/2302 were seized from their possession observing necessary formalities at 02:20 pm & 02:25 pm and arrested them at 02:30 pm and 02:35 pm.

Therefore, the seized articles and the arr estees were handed over to you for taking up further necessary legal procedures.
