Assam Rifle personal Mantripukhri picked us from our residence on 7th May, 2023 and we were dispatched at Motbung on 8th May, 2023 for rehabilitation.

On 28th May, 2023, a Mob of Meitei Community attacked our house located at Paomei Colony (Kairang and Ahallup junction), PS-Heingang, Imphal West District, Manipur, looted and completely destroying all available property including Honda Activa 6G bearing registration No. MN065G 8464. The approximate value of the looted and destroyed properties are assessed to be about Rs. 1.5 Crore (Rupees one Crore and Fifty Lakhs)

I could not report the matter and as well as in time due to the prevailing law and order situation in the State.

I, therefore request you to kindly take up necessary legal actions at the earliest
