I left Imphal for Kangpokpi on 9<sup>th</sup> May, 2023 to save myself and members of my family, leaving my homesteads due to law and order problems in which Kuki-Zo Tribals were targeted. Barely after one month I got information that on 8th June, 2023 at around 6:00 pm, a mob led by suspected state policemen intruded into my house, vandalized and robbed all my valuable assets.
