I have the honour to state that, on Date 6/05/2023 at around 10.00 pm some unknown miscreants suspected to be a members of Meitei Youth Organisation such as Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and Women wings, World Meiteis Council (WMC), Schedule Tribes Demand Committee (STDC), numbering about 1500-2000 persons carrying Sophisticated weapons like AK, SLR, INSAS and 303 rifles forcefully entered our colony.

Baptist Church Mantripukhri is located at Khabam Chumvreithong Maning Leikai (K. Venghom) Mantripukhri, Imphal West under Heingang Police Station, the Church is going full swing. After looting and destroying all the moveable including all the properties to the ground leaving. The approximate value of properties destroyed estimate calculated at about Rs 7,00,00,000 (Seven Cores)

It is therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to Law.
