I have the honour to State that, on date 8/05/2023 at around 11:00 pm some unknown miscreants suspected to be a members of Meitei Youth Organisation such as Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and Women wings, World Meiteis Council (WMC), Schedule Tribes Demand Committee (STDC), numbering about 1500-2000 persons carrying Sophisticated weapons like AK, SLR, INSAS and 303 rifles forcefully entered our colony.

Pastor Quarter Baptist Church Mantripukhri is located at Khabam Chumbreithong Maning Leikai (K. Vengnom) Mantripukhri, Imphal West under Heingang Police Station.

After looting all the moveable properties vandalized our houses including, Steel Armerah, Table, Benched, Sofa Seat 1 nos., Refrigerator, Disk top computer, Gas Stove, Cylinder 3 nos., Kitchen Amirah, Bed nos. 2 seat, Gazer, TV, Washing machine, Gold ring, gold ear ring, personal Dress for all the family members. The approximate value of properties destroyed estimate calculated at about Rs.15,00,0000 (Fifteen lakhs)

It is therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to Law.
