That, while carrying out their above said criminal activities, the said Meitei radical groups were shouting anti-tribal slogans like- "HAO HATLO", "KUKI HATLO, "KANGLEIPAK YAI PHARE", ETC. Hence, the same can be taken as an insult on me and my family for being a tribal.

I, therefore, request you to kindly take strong actions against theperpatrators by registering an FIR/Zero FIR under relevant sections of the statutes of our country.
