Sir,

I am to bring to your kind notice that I am a Scheduled Tribe belonging to the Simte Tribe and a resident of Mantripukhri, Imphal East, Po & PS Heingang.

That, on the 30th of May 2023 at 3:00 pm my above said residence (owned/rented) was attacked, destroyed, looted and burned by a Group of Meetei/Meitei radicals.

These criminals broke open my gate(s), destroyed and looted every valuable property from my "Owned/ Rental" House, and premises worth Rupees 7,00,00,000/- (Approx) and they burnt down all the remaining things.

That, while carrying out their above said criminal activities, the said Meitei radical groups were shouting anti-tribal slogans like- "HAO HATLO", "KUKI HATLO", "KANGLEIPAK YAI PHARE", ETC. Hence, the same can be taken as an insult on me and my family for being a tribal.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/Zero FIR under relevant sections of the statutes of our country.
