

Sir,

I have the honour to state that, on 04-05-2023 at around 1:40 pm some unknown miscreants suspected to be a members of Meitei Youth organization , Meetei Leepun, kangleopak Kanba Lup(KKL), Arambai Tenggol and World Meetei Council(WMC), Schedule Tribe Demand Committee(STDC) numbering about 1000-2000 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our Locality at Lamlongei Lane No. 10 catholic Colony near Khoibu Church Mantripukhri Imphal East, about 45 Km South, after looting all the moveable properties and cash, they burnt down my house with all the household properties including Important Document/Education certificate, Jewellery, Furniture's, utensils Cloths and grains etc.

The approximate value of the lost property is calculated at about Rs. 1,00,00,000(one crore).

It is therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
