I have the honour to state that, on 4<sup>th</sup> May, 2023 at around 8AM some unknown miscreants belonging to Meitei individuals stormed and enter a campus of my residence in next to Ex-MLA Shri. Yamthong Haokip's house, opposite to Imphal Rotary Club, Chumbreithonhg, Mantripukhri Imphal West Manipir- 795002.

In the process these individuals vandalized my properties and looted all my valuable items. The Approximate value of the destroyed and lost properties are estimated to me about Rs. 16,96,000( Sixteen Lakhs ninety six thousand).


