COPY OF ORDER
23-08-2023

The present complaint petition is filed by the complainant for forwarding the case for investigation to OC/Women PS, Imphal East u/s 156(3) CrPC for commission of offence u/s 156/376/417/500/506/34 IPC.

It is stated that the complainant and the accused no. 1 have love affairs with each other for about 28 years. On 09-10-2020 the accused no. 1 had committed sexual assault against the complainant without her will in the name of elopement. Thereafter, the family members of the accused no. 1 refused to fix a date for solemnization of a grand / formal marriage ceremony till now. It is also stated that the accused no. 1 has gone to New Delhi in the name of joining coaching institution for preparation of competitive examination thus avoiding the complainant.

It is stated the complainant already approached the OC/Women PS Imphal East u/s 156(3) CrPC but no action has been taken. It is also stated that the complainant approached SP/ Imphal East u/s 156(3) CrPC and the matter was endorsed to OC Women PS, Imphal East but no action has been taken up till date. The petition is supported by an affidavit.

Considering the allegation, I find sufficient ground for forwarding the case for investigation to OC Women PS, Imphal East.

Hence, the case is forwarded for investigation u/s 156(3) CrPC to OC Women PS, Imphal East.

The O.C Women PS, Imphal East is directed to strictly comply with relevant provision of law laid down in Armesh Kumar -vs- State of Bihar (2014(8) SCALE 250) and provision of 41, 41A Cr.P.C. to prevent unnecessary arrest or detention.

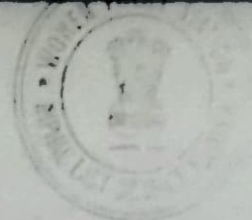

Most Respectfully Sheweth -

1 That, the present Complainant is a bonafide law abiding citizen of India by birth having permanent residence of Yairipok Bishnunaha Mayai Leikai, P.O. & P.S. Yairipok, District-Thoubal, Manipur. She is a student of Dhanamanjuri University, Imphal and studying Master of Arts(M A) in English.

2 That the accused No 1 is the husband of the complainant and the accused No 2 & 3 are the parents of the accused No 1. They are the permanent resident of Yairipok Bishnunaha Mayai Leikai, P.O. & P.S. Yairipok, District-Thoubal.

3 That the brief of the case is that, the Complainant and Accused No 1 have known each other since they hailed from the same locality. They have also been loving each other for about 2/3 years and one day i.e. on 09-10-2020 at about 4 00 p.m. the complainant and the accused No 1 were on a dating at Yairipok Bishnunaha and thereafter the accused No 1 requested the complainant for allowing her to visit one of his friend's house and later on confirmed at Pangei Haotal Thangjam Khunou, P.O. Pangei, P.S. Heingang. On reaching there, the complainant was not allowed to return home by the Accused No. 1 stating that he eloped her. He had also taken the complainant's mobile phone and switch off. Thereafter, they were staying the night at the house of one Asem Boy and Asem (O) Aruna Devi of Pangei Haotal Thangjam Khunou, P.S. Heingang. On the same night, the accused No.1 forcibly tried to sexually assault the complainant but she refused to do so. The accused No 1 had also promised the complainant to get her married with him as soon as possible. The complainant was again threatened by the accused No 1 to face dire consequences if she refused to the demands of the accused No 1 and as such the accused No 1 had forcibly sexually intercourse with the complainant without her free and full consent. On the next day, the complainant was sent back to her parental home by the family members of the accused persons after given due information to the complainant's parents about the elopement of the complainant with the accused No.1. Thereafter, the complainant and her family members requested the accused persons for fixing a particular day/date for solemnization of a grand/formal marriage ceremony with the accused No. 1 but the accused persons have always refused to fix any date.

4 That, in the 1st week of August, 2021, the accused No 1 left Manipur for New Delhi and stayed there in the name of joining coaching institutions for the preparation of competitive examination. The complainant and her family members have always requested the accused persons for arranging marriage ceremony of the complainant with the accused No 1 but the accused persons always neglected to do so. On the other hand, the complainant came to know about having love affairs of the accused No 1 with other girls including one Mrs. Kajal Moirangthem @ Thoibi Moirangthem, aged about 22 years of Khangabok Part-I who was also staying at New Delhi. The complainant and the said Kajal had several talks over mobile phone and she disclosed about her love affairs with the accused No 1 to the complainant and thereafter, the complainant had also told her story of elopement with the accused No 1. The complainant had also found many evidence of having love affairs with the accused No 1 and other girls other than Mrs. Kajal through mobile phone.

Photocopies as well as soft copy of the WhatsApp texts and conversation with audios of the accused No 1 and Mrs. Kajal are enclosed herewith for kind perusal of the Hon'ble Court.

5 That, the complainant had always been trying to convince the accused No 1 for bringing a peaceful settlement by solemnizing a formal marriage ceremony but the accused No 1 and his family members (the accused No 2 and 3) always rejected the proposal of the complainant. Thereafter, the complainant had submitted a written report with the Officer-in-charge, Women Police Station Imphal East, Manipur on 14th August, 2023 but the officials refused to give received signature on the said written report and as such, the Complainant again submitted the same written report to the S.P. Imphal East, Manipur on the same day i.e. 14-08-2023 at about 10:20am by obtaining R.R. No. 19961 of the Office of the Superintendent of Police, Imphal East District, Manipur.

Copies of the written report submitted to the O.C. Women P.S. Imphal East and S.P. Imphal East are also enclosed herewith for kind perusal of the Hon'ble Court.

6. That, on 16-08-2023 at about 4.00pm, the Complainant was informed by the O.C. Women P.S., Imphal East, Manipur to appear the Complainant before her and as such, the Complainant along with her parents went to the said police station. The Complainant told her stories about to the incident to the O.C., WPS/IE and one of her subordinate Lady Police Officer(S.I. Rank) from Yairipok was also present at the time of taking statement of the Complainant. After listening all the stories of the incident, the Complainant and her parents were advised by the O.C., WPS/IE to approach the law court for taking up necessary legal action against the accused persons. The Complainant was further directed by the said O.C. to withdraw her written report from the police station but the Complainant did not withdraw her report from the said police station.

7. That, the accused No. 2 and 3 had also failed to keep their promises and they always supported to the immoral activities of their son, accused No. 1. The complainant had already lost her virginity due to sexual intercourse/rape/sexual assault by the accused No. 1 and as such the life of the complainant is totally spoiled by the attitude of the accused No. 1 and his parents.


8. That, the cause of action arose on 09-10-2020 and place of incident was happened at 'Pangal Haotal Thangjam Khunou, P.O. Pangal, P.S. Heingang, Imphal East District, Manipur and as such the Hon'ble Court has territorial jurisdiction to entertain the present case.

In the circumstances, the Hon'ble Court be pleased to take cognizance of the offence U/S 190 Cr P.C. or to direct the O.C., Women P.S./IE to investigate the case by invoking the provision of law provided u/s 156(3) Cr P.C. for the purpose of causing arrest and punish the accused persons for commission of offences punishable u/s 376, 366, 417, 500, 506 and 34-IPC in the interest of justice.
