Sir,

It may be report that my residential building located at Lamlongei Lane No. 7 Maning Leikai, Mantripukhri, Imphal, Manipur which was left under lock and key since 4<sup>th</sup> May' 2023 was vandalized and looted by unknown miscreants in between 15<sup>th</sup> June to 1<sup>st</sup> July, 2023. The looted items include household furnishing, furnitures, clothing, electronic (i.e. automatic washing machine, refrigerator, two laptops, televion, two microwave ovens), crockeries potteries, etc. worth about Rupees 30 lakhs.

I am therefore to request you to kindly take necessary action at the earliest as per law.




