No. MN01W 0360 white in colour which is used by Mobile Forensic Unit Imphal West by the 5(five) unknown persons with fully loaded armed in their hands and dressed with Commando uniform at Hundred Flower School along the Imphal-Pangei road at about 02:00 pm today while I was returning from DFS, Pangei with M. Yunush who is driving the vehicle.

Madam,

It is to inform that the crime Scene vehicle Gypsy King bearing Regd. No. MN01W 0360 white in colour which is used by Mobile Forensic Unit-Imphal West stopped and hijack by the 5(five) unknown persons with fully loaded armed in their hands and dressed with commando uniform at Hundred Flower School along the Imphal-Pangei road at about 02:00 pm today while I was returning from DFS with M. Yunush who is driving the vehicle. They asked me to hand over the vehicle to them to be used for some time in which I denied and said that it is Government vehicle I cannot handover, I am under the Supervision of Director, DFS, I don't have any power to give away the vehicle, you may please talk to our Director. I had some verbal exchange with them. I strongly objected and said that I cannot hand over the vehicle and said them to meet Director and if our Director allow agree your demand. They asked me to give my contact number and also contact number of Director. I gave the contact numbers. By any how I brought them in the vehicle to meet Director. When we approach the Kanan Devi School, they said to drop them in the Pangei Bazar as there is Central Paramilitary Force in DFS office Gate. So, I drop them at Pangei Bazar as per their instruction and brought the vehicle in the campus of DFS safe and inform the incident to the Director in Telephone since director was out of office. However, after some time, 2 (two) unknown person came inside the campus of DFS and took away the vehicle. Hence the incident, so it is requested to take up necessary action in this regard.
