The present complaint case has been filed by the complainant against the  
accused person for taking cognizance of offense u/s 323,376,406,417 and 506  
IPC along with an application to the Women PS., Imphal East.

Register it as Cril. Misc. (Inv.) Case of 2023.

The Brief facts of the case is that the accused person and the applicant  
were in love relationship. In the para no. 5 of the application, the applicant /  
complainant stated that on the promise of marrying her in 2023, they entered into  
a physical relationship.

Thereafter on 23<sup>rd</sup> July 2023 both of them eloped and on the next day i.e.  
24<sup>th</sup> July 2023 the accused family members and relative came at the  
complainant's resident and informed about the elopement "haidokpa Lakpa".

The 26<sup>th</sup> July 2023 was fixed for 'Waroipot Puba ceremony' but none of  
the accused family members were present. In the Meanwhile one locality woman



of the Thoubal Haokha informed to the complainant's parents that the accused person had eloped one another girl and mentioned that the eloped girl might from Singjamei Chingnga Makha or Singjamei Makha Herangoithong.

Perused the application and heard the counsel for the complainant the complaint application is accompanied by an affidavit. An application of the commission of the offences has been given to the OC/WPS IE, S.P., Imphal East, and DGP Manipur Police, but till now no action / proceeding have been initiated. (copies of the applications are Annexed as Annexure A/1 & A/2)

Considering the nature and gravity of the offence stated to be committed against the complainant, the case is forwarded to OC-WPS/IE for conducting investigation as per law.

By virtue of Section 156(3) Cr.P.C it is hereby directed the OC to investigate the matter.

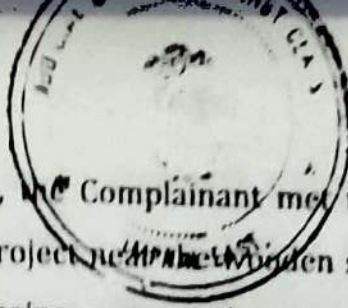

**MOST RESPECTFULLY SHEWETH:**

1. That, the Complainant is law abiding citizen of India having resident of Ngaikhong Khulen, P.O. & P.S. Bishnupur, Bishnupur District, Manipur within the jurisdiction of Hon'ble Court as such she is entitle to all rights, protection and privileges under the law from time being in force in India.
2. That, the brief fact of the case is that, in the year 2020, the Accused person namely **Mr. Longjam Dinesh Singh** (27 years), S/O Lisham Sanahanbi Devi of Thoubal Haokha, P.O. & P.S. Thoubal, Thoubal District, Manipur at present residing at Konung Mamang Leikai, Palace Compund, P.O. & P.S. Porompat, Imphal East District, Manipur had followed the Complainant at her Instragram Account i.e. '**Chachabi**' through his account i.e. '**Dragovic\_7**' and thereafter they had text chat and conversation through **Instragram** Account & its messages inbox section and the Accused person also introduced himself that the Accused person was studying MBBS in Kazakhstan. As such, they came closer & sharing their day todays life and the mobile numbers also provide each other. As per his request, the Complainant met the Accused person at Kongba Nandeibam Leikai while the Complainant was staying at the matrimonial home of her elder sister namely Athokpam Roshini Devi, W/O A. Sanjoy Singh for helping her illness. It was first meeting with the Accused Person as introduce each other. After few days later, the Accused person proposed the Complainant to become his girlfriend, the Complainant also accepted the same as they were in love.





3. That, on 30<sup>th</sup> March, 2021, the Complainant met the Accused person as a dated at Nongthoukhong Project near the Warden site of the Loktak Project Cannel side and they were going on romantic moments in their life and loving each other. As such, every dated of meeting they had in physical relationship. When they visited long drive journey as a dated, the accused person tried to physical relationship with the Complainant inside his car and same has been done even the Complainant reacted the unwillingness to the Accused Person.
4. That, in the year 2022, the Complainant had gotten a Job at Peter England Men's Show Room, Bangalore and she was staying at the ladies hostel i.e. Sri Sai Srinivas Luxury PG Ladies, Bangalore for the aforesaid job. In the meantime, the Accused person returned in Imphal from Kazakhstan as his study vacation. On 16<sup>th</sup> September, 2022, the Accused person also came at Bangalore to meet the Complainant and his personal business. As such, on 18<sup>th</sup> September, 2022, they met each other at the local fast food Restaurant, Bangalore.
5. That, again, on 17<sup>th</sup> February, 2023, the Accused Person came at Bangalore to meet the Complainant, as per his approached they have booked a Hotel Room at Hotel Akshaya Aura, Bangalore and staying two days continuously at the aforesaid hotel i.e. 18<sup>th</sup> to 19<sup>th</sup> February, 2023. During the staying at the said hotel, they had performed the sexual physical relationship as husband and wife. The Accused person also promised to the Complainant that he shall never leave her forever and he shall elope & marry her in this year 2023. On the next day, i.e. 20<sup>th</sup> February, 2023, the accused person left Bangalore for Delhi.



6. That, on 1<sup>st</sup> June, 2023, the Complainant returned in Manipur for her marriage planning and staying at her residence. On the 3<sup>rd</sup> week of June, 2023, they have fixed a date at Moirang as long drive such as they went at Moirang and performed physical relationship with the accused person as per his promised of marriage with the Complainant.

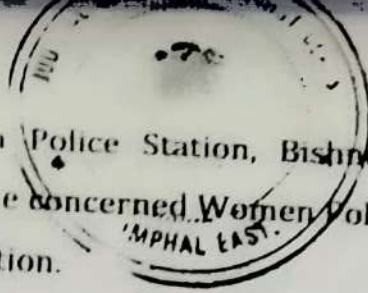
7. That, on 23<sup>rd</sup> July, 2023, when the Complainant visited at the home of her elder sister namely Athokpam Roshini Devi at Kongba Nandeibam Leikai, the Accused person called her through his mobile number +918798129711 to meet him as dated, as such after meeting with her elder sister, the Complainant came out from the residence of her elder sister to meet him. The complainant met him at about 03:45 p.m. at Kongba Nandeibam Leikai and pick-up her and went to the inter-village road of Langdum Imphal East District which inter village road is diverted from Imphal-Kaina Road and thereafter they stayed some moments at the wooden road side park at the wooden site of road side. Due to sunset, they returned at his residence of Konung Mamang Leikai, Palace Compound, Imphal East District as their elopement but the Accused person did not enter his residence. His family members and relatives had already waited the Complainant and the Accused Person at the residence gate of the Accused person and they suggested the Accused Person and the Complainant to stay at Thoubal Haokha as the Accused person's another residence, as such the Accused Person and the Complainant went to Thoubal Haokha. But instead of going to Thoubal Haokha, the Accused person reached at the Thoubal Police Station and detained the Complainant at police custody about two hours. The Accused persons & his family members tried to send back the Complainant at her



home with the help of police, but one police officer denied the planning of the Accuse person. After two hour, the Accused person and his family members took the Complainant from the said police station and keep her at the another resident of Accused person at Thoubal Haokha.

8. On 24<sup>th</sup> July 2023, in the morning, the accused's family member and relative came at the Complainant's resident and informed about her elopement with the Accused person to her parents and her relatives as 'Hidokpa Chatpa or Haidokpa Lakpa' it was customary law and practice of Meitei society. During the discussion of Haidokpa Lakpa as Customary Performance, both parents of the Complainant and Accused Person agreed to discussion matter about the performance of marriage between Accused person and the Complainant on 26<sup>th</sup> July, 2023 at about 08:30 a.m. as Waroipot Puba Ceremony as customary performance like fixing marriage date. On 26<sup>th</sup> July, 2023, the Complainant's parents, her relatives and local elders waited them till 11:45 am for the 'Waroipot Puba Ceremony' but the Accused person's parents and his relatives never came at the residence of Complainant for aforesaid Waroipot Puba Ceremony. At about 11:50 a.m., the Complainant's parents and her family member tried to communicate with them but they did not give any response from them. The Complainant also dialed many phone calls to the accused person but his phone number had changed as betrayed the Complainant. But, in the meanwhile, one locality woman of the Thoubal Haokha informed to the Complainant's parents that the Accused person had eloped one another girl and mentioned that the eloped girl might from Singjamei Chingnga Makha or Singjamei Makha Heirangoithong. Thereafter, the Coplainanat along with her parents went to the Women Police Station, Bishnupur and orally complained the incidents occurred & very acts of the

accused person but the Women Police Station, Bishnupur directed the Complainant to file a complaint at the concerned Women Police Station, Imphal East, Porompat as original jurisdiction.



9. That, on 28<sup>th</sup> July, 2023, the Complainant along with her parent went to Women Police Station, Imphal East, Porompat and filed a complaint to the concerned Women Police Station, Imphal East, Porompat against the Accused person but the concerned Women Police Station, Imphal East, Porompat do not lodged any FIR against the accused person till now. The Complainant came to know that one of the Accused person uncle is MPS Officer at the Manipur Police Department so he pressure to the Women Police Station, Imphal East, Porompat for not lodged an FIR case and legal action against the Accused person. In the meantime, on 1<sup>st</sup> September, 2023, at about 2 p.m., the Complainant requested to the concerned Women Police Station, Imphal East, Porompat to provide her a copy of her complaint application but the Concerned P.S. denied her request. Further they told her that if she wants the aforesaid complaint copy, she should withdraw her complaint from the concerned Women Police Station, Imphal East, Porompat.

10. That, the Complainant came to know that in the year 2022 the accused person completed his MBBS Degree in Kazakhstan and the accused person also cleared (MCI Exam., 2023 conducted by the Medical Council of India and now the accused person has been practicing his professional intern coaching at Sija Hospital, Langol)

11. That, the very act of the Accused person, the Complainant came to know that he used her for his sexual physical enjoyment and lust as time pass at any



time by using false promises. The accused person committed the offensive act of rape, cheating and criminal breach of trust, hurt & torture mentally and criminal intimidation.



12. That, the Complainant had submitted her Complaints before the concerned DGP and SP-Imphal East on 05/09/2023 to take initiative action and giving direction to lodge an FIR against the above named Accused Person. But there is no any kind of action taken from the concerned Police Stations. The concerned Women Police Station, Imphal East, Porompat advised to the Complainant to file a complaint before the Hon'ble Court.

Hence the petition.


13. That, the very act of the Accused Person, the reputation of the Complainant has loss in society and also physically and mentally tortured the Complainant. The accused person, who has committed criminal offences which is punishable by law and it is highly required to punish him according to law.

14. That, the Accused Person have committed the punishable offences under sections of 323 (Punishment for voluntarily causing hurt), 376 (Punishment for Rape), 406 (Punishment for Criminal Breach of Trust), 417 (Punishment for Cheating) & 506 (Punishment for Criminal Intimidation of the Indian Penal Code, 1860).

### **PRAYER**

In view of the facts and circumstances it is, therefore, prayed that Your Honour be pleased:-

- i. to register the application as criminal complaint case;

- 
- ii. to take cognizance of offences under section 190 and 200 of Cr.P.C., 1973;
  - iii. to pass an order of direction to the concerned Officer-in-Charge of Women P.S. Imphal East, Porompat for the investigation and lodging an FIR;
  - iv. to investigate against the accused person and issue non-bailable arrest of warrant against the accused person;
  - v. to punish the accused person and
  - vi. to pass any order and orders the Hon'ble Court deem fit in the interest of justice.
