Subject: *For information against unknown assailant/goons for burning down my village (Chaningpokpi) on 6th May, 2023 (Saturday) and the incident thereof.*

Sir,

On the fateful day of 6th May, 2023 (Saturday) at around 2:30 PM, Chaningpokpi Village was attacked and burned down by the unknown assailants or goons suspected to be 'Arambai Tenggol' from Meitei community, leading to the following incident and damages against the village as given below;

1. Complete burning of houses - 22 out of 32
2. House damages - 04
3. Church damage - 01
4. School properties damaged & burnt (Benches, Chair, Tables etc)
5. Shop damage/burned - 03
6. Granary/food grain store burned - 11
7. Dead - 1 (a policeman by name Mr. Thanglenmang Khongsai, age about 30 S/o Late Jangngam Khongsai with one motor bike which he rides on was taken away.)
8. Damage/burned down vehicles : 1 TVS Jupiter, 1 Aprilla (Piaggio) Regn. No. MNO 2G 3549 , 1 Motor bike (All related document were burned down)
9. Looted property: 1 Male pig, 1 tolu water pump, 1 Solar pate + inverter, stand fan were stolen by CDO I/E who came with two gypsy at the advice/instigation of Mr. Shyamkumar Meitei, MLA of Andro A/C. (As claim by himself through phone call and conversation with the village Chairman Mr. Hemjathang Khongsai.) This Sl. No. 8 incident happened on 9th May, 2023 at around 9:30 AM.

Approximate value of losses estimated to be around Rs. 1.5 Crore.

My appeal to the higher authority to catch the personnel involved and responsible for that helnous acts must be brought to justice. Since, 6th May, 2023 and till now, the victim villagers (except some men who were left to guard the village) of about 116 (female 55 & 61 male) who fled their homestead in fear of unknown miscreants are camping and relieved at Chepu Yaolen Village, Ukhrul District, Manipur.

The miscreant had left some houses unburnt was only due to the intervention of Security Force like BSF personnel posted in Phuramakhong which falls under their jurisdiction.

So, it is my humble request to the concerned authority to look into this heinous crime and action perpetrated by goons, who seemed to be set free hands by the Govt. to do anything they wished are booked and arrested according to the law of the land immediately. And also compensate the loss properties and rehabilitation process be initiated for remedial measure in public interest.
