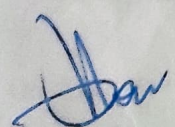

Sir,

With due respect and regard, I have the honour to lay down the following few lines under your kind consideration and necessary action.

That, on 24/5/2023 at about 4:30 pm while my father namely Lousambam Irabanta Meitei(75) S/o(L)L. Irabot Meitei of Khurai Thangjam Leikai and my mother namely Lousambam (O) Jamuna Leima(70) W/o L. Irabanta Meitei of Khurai Thangjam Leikai were practicing rituals(they are laipus) at Nongpok Ningthou Panthoibi Sanglen, Takhel Awang Leikai after a having feast served by the Lai Haraoba Committee in c/w Annual Lai Haraoba, one person namely Moirangthem Dolen Meitei(52)yrs S/o (L) M. Sito Singh of Takhel Awang Leikai physically assaulted them by kicking and punching them violently without giving any reason. As a result of which they were seriously injured on their persons and evacuated to JNIMS, Porompat for medical Treatment.

I therefore, request you to kindly take up necessary legal action against him(Moirangthem Dolen Meitei).
