Sir,

I have the honour to report that I am a resident of Pourabi village under Lamlai P.S. I am a private teacher by profession. I run a boarding specially for class X(BOSEM) under the name GEM PUBLIC SCHOOL, Pourabi. On, 19/6/2023 at around 6:05 pm some armed unidentified youths of around 10 in number came at my office and told me to bring out the 2(two) INSAS Rifles about which I don't have any knowledge. When I told them that I don't know anything about those INSAS Rifles, one among them took out a pistol and pressed the muzzle directly against my abdomen and told me that he will kill me if I fail to produce the said INSAS Rifles. Meanwhile, they started searching the whole school campus to find the INSAS Rifles but did not find it. They took away the CPU(Memory Card) of the CCTV camera installed at the School campus. They had come in three vehicles with unknown regn. numbers i.e. one Bolero(white), one car(red) and another car.

I, therefore request you to kindly take-up necessary legal action against the unknown armed persons.
