Sir,

I, the undersigned have the honour to report that on 23/6/2023 at about 7:00 PM; Hon'ble Minister (CAF & PD/PHED) Leishangthem Susindro Meitei (Yaima) along with the escort party visited at Sabungkhok to see some problems happened in between Meira Paibis at Sabungkhok and on the way back reaching Chingarel Tejpur some women folk forcibly stopped the Hon'ble Minister Carcades. In that the Minister came down from the vehicle to see the reason and try to convince the public but the youths who were behind the Meira Paibis try to assault the Minister. On seeing the situation, I use my service weapon (9mm Pistol) and blank fires some rounds to rescue the Minister and disperse the mob. As such the Minister was rescued from the spot.

It is therefore requested to take up necessary legal action against the public who were involved in committing the crime. I could not report the matter in time as I and the Minister were heavily engaged in present law and order situation.
