It is learnt that today, the 4th May' 2023 at about 02:40 pm, a gang of valley unknown youth numbering about 3000 (three thousands only) attacked suddenly to Kamuching village under Kangpokpi District, dominated by Kuki Vaiphei, Schedule tribes consisting about 30/40 houses in which all the houses were burnt down and gutted into fire and there was some exchange of gun firing on both sides. Further, learnt that some villagers sustained grievous injuries on their persons and they all including the villagers evacuated to a safety places. After commission of the crime, all the culprits disappeared to unknown direction.

Hence, a regular case on suo motto under FIR No. 3(5)2023 TBL-DAM-PS U/S 447/435/400/326 IPC and 25(1-a) Arms Act has been registered for the purpose of investigation.
