It is learnt that a gang of valley unknown youth numbering about 4000 (four thousands) attacked suddenly to Grel-jang village under Kangpokpi District, dominated by Kuki Vaiphei, Schedule Tribe consisting about 14/15 houses in which all the houses were burnt down and gutted into fire. After which the gang proceed to Bongbat Khullen village under Kangpokpi District, Schedule Tribe consisting about 115/120 houses in which all the houses were burnt down and gutted into fire and there was some exchange of gun firing on both sides.

Further, another village namely Themdawi, S. Phaiza and K. Nungmanbi village under Kangpokpi District dominated by Kuki Vaiphei, Schedule Tribe consisting about 30/35 houses including one Private School were also burnt down and gutted into fire. After commission of the crime, all the culprits disappeared to unknown direction.

Hence a regular suo mottu case under FIR NO. 4(5)20: TBL- DAM PS u/s 447/435/400/326/PC & 25(1-a) A. Act has been registered for investigation.

It is learnt that today, the 6 May' 2023 at about 4:00 pm, a gang of valley unknown youth numbering about 3000 (three thousands only) attacked suddenly to Chaningpokpi village under Kangpokpi District, dominated by Kuki, Schedule tribes consisting about 10 houses in which all the houses were burnt down and gutted into fire and also hearing gun firing from the miscreant side. Further, learnt that some villagers sustained grievous injuries on their persons. After commission of the crime, all the culprits disappeared to unknown direction.

Hence, a regular case suo mottu under FIR No. 5(5)2023 TBL-DAM-PS U/S 447/435/400/326 IPC and 25(1-a) Arms Act has been registered for the purpose of investigation.
