With due respect, I have the honour to state that the following few lines for your kind consideration and necessary action.

That, on the 3rd May 2023 at around 7:30 pm, unknown miscreant belonging to Arambai Tenggol, Kangleipak Kanba Lup, Meitei Leepun numbering about 200-300 stormed into my campus and destroyed, looted and burned down my building which was a three storeyed, other structure, household items properties, personal library books, electronic item, Gold ornaments valuable clothes and other items worth approximately about 2,90,00000/- (two crores ninety lakhs only) at Achanbigei Awang Leikai, CMC road Koirengei, opposite Poirei Nawakon near Hiyai Circuit, PO-Mantripukhri, PS-Heingang, Imphal East-795002, Manipur.

I could not report the incident to my concern police station as well as in time due to the prevailing situation in the state.


