

Subject: Complain Report.

Sir,

I am to state that, on 31st May 2023 at about 4:30pm, my village Chingdai Khullen village under Saikul Police Station Kangpokpi was under attack by meetei miscreants including Arambai Tenggol, Meetei Leepun, Kangleipak Kanba Lup (KKL) and a women folk numbering about 1000+ member carrying sophisticated weapons and Assault Rifles like AK Rifles, License Gun, SBBL, Molotov and knives etc.

As a Result, Many houses and Church were burnt down to ashes. After looting all my Properties they burnt down my house and properties etc.

List of properties both movable and immovable looted, burnt down are given below.

- 1) 4 house which include Hotel, Granary, living room and kitchen
- 2) Furniture include 2 wooden Almirah, 4 bed with Mattress, 2 sofa sets, dinning Table with 7 chairs Gas Box etc
- 3) Electronic items tv-set, fridge washing machine stand fan etc.
- 4) Paddy field (occupied by Meetei) 8 acres.
- 5) Gold earring, necklace and utensil etc.

The approximate total loss of properties looted and burnt down properties worth 2.5 crore.

I therefore, kindly requested your good office to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice.

I hereby lodge my complain at Kangpokpi Police Station as I had fled from my residence to save myself and my families from the miscreant and rioters.
