It is learn that on 09/05/2023 at about 12:55 pm some unknown persons of hill district numbering about 20/30 equipped with arms ammunition burned down 2(two) four wheeler vehicles (one Maruti Van and one Maruti 800 Car) belonging to valley community. While the Meitei people consisting of 6(six) men members and 2(two) women folk were travelling with the said vehicles at Bongbal Khollen village, Kangpokpi District. The vehicles were burnt in assets. However, no casualty was found on the side of victims. All the Meitei community retreated towards their respective villages.

Considered necessary to register a regular case Suo Moto as FIR No. 6(5)2023 TBL-DAM-PS U/S 400/435 IPC & 25(1-a) Arms Act for the purpose of investigation.
