Subject:- Report on looting, vandalism and burning of house, household items/assets.

Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

1. That, I Finkhiong Vaiphei aged about 54 years, w/o (L) Paogouhang, belonging to the KUKI tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that, I am a permanent resident of Happy Valley, P.O./P.S. Sagolmang, Kangpokpi District, Manipur-795_____.
2. That, at about 9:00 am/pm on the 03rd May 2023, a huge contingent of armed radical Meitei/Meitei suspected to be members of the Arambai Tengol and Meitei Leepun along with various state forces like Manipur Police Commando and Indian Reserve Battalion (IRB) attacked our villages and in the process, they have looted, vandalized and torched my house.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs 57 lakhs (Rupees fifty-seven lakhs only) only.
4. Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at B. New Moltuh, Churachandpur

In the given circumstances, I humbly pray you to kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
