**Subject:** - First Information Report on the crimes of looting, vandalism, arson attack and discrimination of Scheduled Tribes.

Dear Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

1. That, I am a Scheduled Tribe belonging to the Kuki Tribe, a recognized Scheduled Tribe under the Constitution of India. And, I am a permanent resident of P. J. Jorandhai Village, Khamenlok Area P.S. Saikul District- Kangpokpi, Manipur.

Pengol Meitei Leepun 2. That, at about 11:30 AM/ PM, a huge contingent of armed radical Meitei/ Meetei, Arambai along with the Manipur State forces like the Manipur Police Commando, the Indian Reserved Battalion (IRB) attacked our village and in the process, they have looted, vandalized and torched my house on the 14<sup>th</sup> June, 2023.

3. That, it may be reported here that the miscreants were shouting slogans like- "KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities.

4. That, it may also be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs. 34 Lacs 50 K (Rupees Thirty Four Lakhs and Fifty Thousand) only.

In the given circumstances, I humbly pray you to kindly register an FIR/ ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
