Sub:- Report.

Sir,

With due respect, I have the honour to state that on 04/05/2023 at about 5:30 pm, a mob numbering about 500 persons stormed the Island Outpost, Kangpokpi District, under the jurisdiction of Thoubal Dam Police Station by holding sticks and deadly weapons. The Unruly mob was against the Tribal Solidarity March called by ATSUM in hill districts of the State on 3rd May, 2023. The Police personnel posted in Island Outpost confronted with the Mob by firing in the air. However, the unruly mob vandalized the doors of the Barrack and the Room where arms and ammunition are kept and snatched away 3(three) nos. of SLRs i.e, (1). Butt No. 308, Body No. 15369862, (2). Butt No. 503 & Body No. V4664 and (3). Butt No. 505 and Body No. V4950 with 11(eleven) nos. of Magazine and 220(two hundred and twenty) nos. of 7.62 ammunition SLR, and 2(two) nos. of 303 Rifles i.e, (1). Butt No. 63 and Body No. M1943B112758 and (2). Butt No. 31 and Body No. M19441191 with 2(two) nos. of Magazine and 20(twenty) nos. of ammunition of 303 Rifles. The Mob was later dispersed by the Police personnel stationing in the Outpost by firing at last resort after confrontation.

It is therefore, requested you to kindly take up necessary legal action against the culprits.

Delay of report in written is due to unable to turn up at this concerned PS as there was a tense law and order situation in the area during the last few days and also we are heavily engaging in law and order duty.
