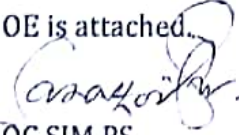

Subject: Request to file OFIR

Madam,

I am to state that I am a Research Scholar from department of Zoology, Manipur University, Canchipur staying in Ladies Hostel no. 2 bearing room no. 206. On the night of 30th May 2023, a mob of miscreant of mitei community with dounkard, carrying wooden sticks and knives rush in through MU main gate and we were the first under attacked. They started hitting hostel gate, shouting and calling out to send the 'kuki women' from the hostel with full intention of hurting us. There were 4 of us but with the intervention of hostel authority we were unharmed - then again they started attacking my hostel for round two. With the help of army, we were pickup and escaped the hostel around 2:30 a.m. Leaving behind all books, document, study and research materials, all clothes and necessities. The attacked that night left me with incomparable trauma both emotionally and physically.

In this connection, I request you to register an FIR and take further necessary action at the earliest.
