Singjamai, I was attacked by Meitei Community causing injury to my wrist (hand) where they tied me up and blindfolded me. Fortunately, I managed to escape from these criminal who tried to kill me.

That, while carrying out their above said criminal activities, the said Meitei radical groups were shouting anti-tribal slogans like- "HAO HATLO", "KUKI HATLO", "KANGLEIPAK YAIPHARE", etc. Hence, the same can be taken as an insult on me and my family for being a tribal.

I, therefore request you to kindly take strong actions against the perpetrators by registering an FIR/ZERO FIR under relevant sections of the statutes of our country.
