

Sir,

With due regards, I beg to state that today on 29/08/2023 at about 2.00 pm received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives in the jungle of Ningel Mamang Ching near Irong village for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with 33 AR Somrei led by Addl. SP(Ops)/TBL assisted by OC/CDO-TBL under the supervision of SP/TBL have rushed to the spot immediately and launched a massive operation at 03:00 pm by using metal detectors. On searching and found the undernoted articles i.e. (i) 20 (Twenty) Nos. of 5.56 mm live rounds, (ii) 04 (Four) Nos. of HE(High Explosive) Hand Grenade, (iii) 03(Three) Nos. of Tube Launcher and (iv) 01(One) Chinese Hand Grenade from the spot at 04:30 pm. And further seized the aforesaid articles at 05:00 pm by observing necessary formalities. The massive searched Operation was conducted from 03:00 pm to 06:00 pm on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
