With due regards, I beg to state that today on 01/09/2023 at about 2.30 pm received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives in the jungle of Yerum Ching near Sharam village for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with 33 AR Somrei led by Addl. SP(Ops)/TBL assisted by OC/CDO-TBL under the supervision of SP/TBL have rushed to the spot immediately and launched a massive operation at 03:00 pm by using metal detectors. On searching and found the undernoted articles i.e. (i) 1 (One) 303 Rifle along with magazine (ii) 02 (Two) Nos. of HE(High Explosive) Hand Grenade, (iii) 1 (One) Insas Magazine (iv) 01(One) Carbine Magazine and v) 1 (One) SLR Magazine from the spot at 04:00 pm. And further seized the aforesaid articles at 04:25 pm by observing necessary formalities. The massive searched Operation was conducted from 03:00 pm to 06:00 pm on the same day.
