With due regards, I beg to state that today on 04/09/2023 at about 2,00 pm received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at Ngamukhong near Phungrei Ching for using offensive act against State Security Forces and CAPF.
