Sir,

With due regards, I beg to state that today i.e. 15/09/2023 at about 2.30 pm received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at the foothill in between Aripat Village and Kwarok Maring Village for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with 33 AR Thoubal COB led by Addl. SP(Ops)/TBL assisted by OC/CDO-TBL under the supervision of SP/TBL have rushed to the spot immediately and launched a massive operation at 03:00 pm by using metal detectors. On searching and found the undernoted articles i.e. (i) 1(one) Carbine bearing Regd. No. N915225808 SAF 1992 along with one magazine, (ii) 5 (five) Nos. of live rds, from the spot at 05:10 pm and further seized the aforesaid articles at 05:20 pm by observing necessary formalities. The massive searched Operation was conducted from 03:00 pm to 06:00 pm on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
