



Today i.e. 18/7/2023 at 8:05 pm, received an information that on the same day at about 7:55 pm, one car Suzuki SX4 bearing regd. no. MN05A5479 proceeding from Thoubal towards Wangjing side along NH102 dashed one stationary vehicle Suzuki EECO van bearing regd. no. MN01AS1338 heading towards Wangjing side on its back portion at Wangjing Bazar due to rash or negligent driving on the part of the unknown driver of Suzuki SX4 car. As a result of it, some unknown occupants of both vehicles received severe injuries and both vehicles were also badly damaged. The injured persons were evacuated to hospital for medical treatment.
