Sir,

I have the honour to report that today i.e. 10/08/2023 at 12:30 am received an information that some unknown miscreants had tried to snatch vehicles from passerby along IV road of Leishangthem and Mayang Imphal road at Thoubal Leishangthem Awang Leikai.

Based on the information, I along with police personnel rushed at the spot and found two individuals whom they were later on identified as (1) Md. Ajad Khan (28) yrs S/o Amjad Ali of Moreh Ward No. 5 Muslim Nagar, Tengenoupal District A/P Sora Awang Leikai and (2) Abdul Warish (21) yrs S/o Abdul Rashid of Sora Awang Leikai. Further, they stated that they came in one Baleno car B/Regn. No. MN06LA4212 and Grey in colour and the said car was forcibly taken away by some unknown miscreants towards Mayang Imphal side on the same day at @ 12:20 am. Accordingly, two individuals mentioned above were rescued.

It is, therefore, requested to kindly take up necessary action.
